

FFB Nucleus Production (in '000 MT)




Highlights:

- In 1H2021, FFB nucleus production grew 1% yoy to 616 thousand tonnes. In line with higher FFB nucleus and external production, CPO production increased 4% yoy to 164 thousand tonnes.
- CPO sales volume increased 8% yoy to 169 thousand tonnes while PK products sales volume increased 12% yoy to 47 thousand tonnes.
- Lonsum recorded sales of Rp2.18 trillion, increased 39% yoy mainly due to higher sales volume and average selling prices (ASP) of palm products. In 1H2021, CPO and PK ASP increased 25% yoy and 56% yoy, respectively.
- In 1H2021, Lonsum reported gross profit Rp755 billion (+173% yoy), operating profit Rp610 billion (+692% yoy) and EBITDA Rp803 billion (+124% yoy). Core profit increased 110% yoy to Rp491 billion in 1H2021.
- Profit for the period attributable to owners of the parent increased 445% yoy to Rp501 billion mainly due to higher operating profit which partly offset by higher income tax expense.
- Lonsum maintained its healthy financial position with total asset Rp11.61 trillion including cash and cash equivalents of Rp2.69 trillion and no bank loan as of June 30, 2021.


1H21 Sales Mix



CPO Production (in '000 MT)



Ikhtisar:

- Pada 1H2021, produksi TBS inti tumbuh 1% yoy menjadi 616 ribu ton. Seiring peningkatan produksi TBS inti dan eksternal, produksi CPO naik 4% yoy menjadi 164 ribu ton.
- Volume penjualan CPO naik 8% yoy menjadi 169 ribu ton dan volume penjualan produk PK naik 12% yoy menjadi 47 ribu ton.
- Lonsum mencatat penjualan sebesar Rp2,18 triliun, naik 39% yoy terutama karena peningkatan volume penjualan dan harga rata-rata (ASP) produk sawit. Pada 1H2021, ASP CPO dan PK naik masing-masing sebesar 25% yoy dan 56% yoy.
- Pada 1H2021, Lonsum mencatat laba bruto sebesar Rp755 miliar (+173% yoy), laba usaha Rp610 miliar (+692% yoy) dan EBITDA Rp803 miliar (+124% yoy). Core profit meningkat 110% yoy menjadi Rp491 miliar pada 1H2021.
- Laba periode berjalan yang dapat diatribusikan kepada pemilik entitas induk meningkat 445% yoy menjadi Rp501 miliar terutama seiring kenaikan laba usaha yang sebagian diimbangi oleh kenaikan beban pajak penghasilan.
- Lonsum mempertahankan posisi keuangan yang sehat dengan total aset Rp11,61 triliun termasuk posisi kas dan setara kas Rp2,69 triliun dan tidak adanya pendanaan melalui hutang bank pada tanggal 30 Juni 2021.
